## CALL FOR APPLICATIONS FOR THE AWARD OF RESEARCH FELLOWSHIPS

Regulations on Research Fellowships pursuant to Italian Law n. 240/2010  
University of Florence, issued by Rector's Decree n. 654 of 22.06.2015

### Art. 1 – Purpose

Applications are invited for the selection running at the Department of Mathematics and Computer Science of the University of Florence for the award of 1 research fellowship grant, with a duration of 12 months, and renewable according to the terms laid down in the University Regulations (D.R. 654 of 22.06.2015), in the field of Algebra (SSD MAT/02) to carry on research activities within the project entitled "*Finite Groups and their Representations*", according to the annexed Activity Programme. The call for applications for research fellowship, issued in compliance to the aforementioned University Regulations, is approved by the Department concerned in the session of 16 May 2019.

The activities shall be carried out under the supervision of a Tutor identified by the Department as Prof. Silvio DOLFI, in a non-subordinate relationship with no set working hours, starting from 1 October 2019

### **Art. 2 – Requirements for candidacy and for renewal**

The selection is open to candidates in possession of the following qualifications:

- PhD in Mathematics, with a minimum three-year duration;
- Knowledge of the English language;
- No criminal convictions or pending prosecution;
- Appropriate scientific and professional CV

Candidates must possess the admission requirements by the deadline for submission of applications stated in the call.

The renewal of the research contract is subject to the favourable evaluation of the research activity by the Tutor and by a Department Commission, and to the actual availability of budget resources.

### **Art. 3 – Eligibility restrictions**

Any person who are related by marriage or by blood up to the fourth degree to a professor working in the department or unit issuing the call , or to the President (Rector), General Manager or a member of the Board of Governors of the University cannot, by law, participate to this selection.

The selection also excludes anyone who has held research fellowship contracts with any institution, pursuant to Italian Law n. 240/2010, for a period which, summed to the foreseen duration of this contract, exceeds a total of 6 years, excluding any period in which the contract coincided with a PhD without scholarship, for the maximum limit of the legal duration of the PhD programme.

Furthermore the selection is not open to anyone who has had research fellowship or fixed-term researcher contracts at the University of Florence or any other state-funded, private-funded or distance-learning Italian university pursuant to articles 22 and 24 of Italian Law 240/2010, or with any other body list in paragraph 1 of art. 22 of Italian Law 240/2010 for a period which, summed to the foreseen duration of this contract, exceeds a total of 12 years, even if not consecutive. For the purposes of the duration of the above-described period, in compliance with the laws in force any period of maternity or sick leave shall not be calculated.

#### Art. 4 – Application

The deadline to submit applications is : 21 August 2019.

Applications received beyond the deadline will not be accepted.

Applications must be submitted using the template provided at the end of this call

When submitting by post, courier or hand, the application must be in a sealed envelope bearing the title indicated in the call for proposal for Research Fellowship, and addressed to the Director - Dept. of Mathematics and Computer Science 'Ulisse Dini' Viale Morgagni 67/A 50134 Florence (Italy).

If sent by international courier, applications must be sent to address indicated above , and in this case the shipment must occur before the deadline. The shipment date stamp will be considered as the date of submission.

Or:

- That they possess an academic qualification obtained abroad, which is duly declared equivalent by the relevant authorities.

The candidates with a qualification obtained abroad must attach to their application a translation into Italian of it, accompanied by a self-declaration stating that it is a faithful translation of the original certificate according to the template form hereby attached. The foreign qualification, without the necessary legalisation documents may be declared admissible as such by the Evaluation Commission, solely for the purposes of admission to the selection procedure.

The successful candidate who has obtained their qualification in a country outside of the European Union, must provide the Department, in the same manner as laid down for the presentation of applications, the official translation with a declaration of value (Dichiarazione di Valore in Loco) of the foreign qualification issued by the competent diplomatic representation or Italian consulate in their home country, in accordance with the applicable laws, within 30 days of winning the selection procedure. If the documents are not received by the Department within this time, the candidate will not be awarded the contract.

Candidates must also enclose with their applications the following:

- Their scientific and professional CV;
- Certificates of all qualifications considered useful for the selection. Academic and professional qualifications issued by an Italian public administration body must be self-certified or submitted as a photocopy, by way of a self-declaration (as per the attached form) that the photocopy is a true copy of the original (pursuant to articles 46 and 47 of DPR 445/2000);
- A photocopy of a valid Identification Document;
- A list of publications, certificates and any awards relevant to the call;
- The CINECA Form duly filled in. This is for the subsequent inclusion of the successful candidate's record inside the Italian Ministry for Education, University and Research (MIUR) database. Such data can be accessed on the website <https://loginmiur.cineca.it>, upon registration.

Candidates are admitted to the selection procedure with reserve. At any time, even after having taken part in any tests, the Administration may, with due justification, exclude any candidate from the selection procedure. The concerned candidates will be notified of such exclusion in writing.

#### **Art. 5 – Comparative assessment of the candidates and the Evaluation Commission**

The candidates will be assessed comparatively by an Evaluation Commission selected by the Board of the Department. The Evaluation Commission will be composed of the Tutor and two members chosen among tenured professors and researchers in the same scientific area as the research activity outlined in the call.

The selection procedure focuses on the examination of requisites laid down by the Evaluation Commission, the candidate's scientific-professional curriculum and the scientific work and publications resulting from the documents enclosed with the application, as well as an interview, aiming to verify the suitability of the candidate for carrying out the research project.

Candidates can apply to be interviewed by videoconference (remote interview via skype accepted) on the same date.

In order to be admitted to the interview, candidates must present the same valid ID attached to the application; the candidate have to declare the skype nickname in the call form; the commission of valuation have to establish for the skype interview a meeting time compatible with the time zone of the candidate; the candidate has to be identified in the skype interview with the same ID or passport, just presented for the call, also the signature of the contract.

The Director of the Department shall confirm in writing his/her approval of the shortlist drawn up by the Evaluation Commission.

The final results will also be published in the "Official Register" (<http://www.unifi.it/vp-10329-official-register.html>). Any appeal against the final results' decree, should be made in writing, within ten days from the publication of said results. The claim must be addressed to the Director of the Department.

#### **Art. 6 – Contract**

The successful candidate will be invited to sign a research contract with the Department within 30 September 2019.

Failure to accept and sign the contract within the deadline mentioned above shall lead to the forfeiture of the candidate's right to sign the contract.

In case of forfeiture, renunciation or failure to show up on the contract's execution date without justifiable reason by the successful candidate, the research grant shall be assigned to the candidate ranking next to the renouncing applicant. The ranking will be valid for 90 days after its publication on the Official University Register.

The contract has a duration of 12 months and may be renewed in accordance to the terms outlined in the University Regulations concerning research fellowships (D.R. 654 of 22/06/2015).

The gross stipend of the research fellowship contract shall be € **19.541,88** per annum. The amount is exempt from withholding tax but includes social security charges the Research Fellow is subject to.

The amount will be paid in deferred monthly payments.

The Research Fellow will need to take up compulsory insurance policy against accidents, for the research activity described in this contract. He/she has the option to underwrite the insurance policy that the University has collectively underwritten or to take up a private insurance of his/her choice.. #### **Art. 7 – Rights and Obligations**

The contract is governed by the following regulations concerning leave: for obligatory maternity leave, the provision laid down in the Decree of the Ministry of Labour and Social Welfare of 12.07.2007, published in the Official Journal n. 247 of 23.10.2007, and for sick leave, article 1, paragraph 788, of Italian law n. 296 of 27.12.2006 and amendments.

The research activities are carried out under the supervision of a Tutor, in a non-subordinate relationship with no fixed working hours. The Research Fellow shall personally carry out the required activities laid down in the Activity Programme. No other person shall replace or substitute for him/her.

Research Fellows assigned to medical and clinical areas may carry out care activities exclusively for the healthcare organisations indicated in the specific agreements between the university and the health board.

Within six months of the research programme's execution date, the Research Fellow shall present a progress report about the activity carried out and the results achieved up to that point; the report shall be submitted to the research Tutor.

At the end of the work, the Research Fellow shall present a detailed final report to the Board of the Department, describing the activities carried out, the results achieved and the scientific developments, accompanied by the report written by the Tutor.

#### **Art. 8 – Intellectual Property**

Industrial Property rights over the results achieved by the Research Fellow in the execution of activities undertaken on behalf of the University are regulated by the University Regulations on Inventions deriving from research activities (Regolamento relativo alle invenzioni effettuate in occasione di attività di ricerca svolte da personale universitario - D.R. 595/2013). Article 2, in particular, states that: "The right to patent an invention realized by university researchers during research activities, in case that the research activities were not funded in whole or in part by private entities or realized with specific research projects funded by public entities different from University, belongs to the inventor or the co-inventors according to article 65 of the industrial property code (Legislative Decree n. 30/2005)."

According to Article 10 of the University Regulations on Inventions, by signing the contract, the Research Fellow automatically accepts the application of the above Regulations.

#### **Art. 9 – Non-accumulation, incompatibility, leave**

1. The position of Research Fellow is incompatible with the following positions:
  - a. Fixed-term and full-time staff employed by the bodies listed in art. 22, para.1 of Italian Law n. 240/2010



- b. Persons employed by any Public Administration body other than those listed in letter a) refer to the provisions of point 2 below
  - c. Persons with fixed-term research contracts with any university or equivalent academic institution worldwide
  - d. Adjunct professors with official teaching responsibilities in degree programmes or specialisation schools in any university or equivalent academic institution in Italy or abroad
  - e. Persons enrolled in any first, second or single cycle degree programmes, PhD programmes with scholarships or specialisation school
  - f. Persons awarded with research fellowships by any other body in Italy or abroad
2. Employees of the public sector other than those listed in point 1 letter a) with a fixed-term, permanent or part-time contract, must take unpaid leave of absence for the whole period of the research contract.
3. The accumulation of the research fellowship contract with study grants awarded for any purpose is not permitted, with the exception of those granted by national or foreign institutions for the purposes of integrating the research activities stated in the contract with study periods abroad.
4. The above requirements must be possessed by the candidates as of the date of execution of the contract. The successful candidate shall sign a specific affidavit undertaking to notify the Department of any variations to the declared situation as soon as they occur.

#### **Art. 10 – Suspension**

The research activity shall be suspended for maternity reasons pursuant to the decree of the Ministry of Labour and Social Security of 12.07.2007 published on the Italian Official Journal n. 247 of 23.10.2007.

During the maternity leave, the indemnity paid by the Italian National Institute of Social Security (INPS) is integrated by the University fund up to the entire grant amount. The maternity leave shall be made up for after the natural conclusion of the research fellowship contract, in accordance with current legislation.

The research activity can also be interrupted for serious illness or serious family reasons; the suspension months could be made up for after the end of the natural conclusion of the research fellowship contract, upon agreement with the research Tutor and within the limits of the available funds.

Sick leave is regulated by article 1, section 788 of the Italian legislation n. 296 of 27.12.2006 and following amendments.

Suspension decrees shall be decided by the Director of the Department coordinating the research fellowship.

#### **Art. 11 – Resolution**

The Board of Department can decide, upon motivated request by the Tutor, for the resolution of this contract according to article 1453 and ff., of the Italian civil code, in the event that the Research Fellow does not carry out the research activities, without a justified reason or is found liable of serious and frequent defaults.

The resolution decree shall be disposed of by the Director of the Department coordinating the research fellowship.

#### **Art. 12 – Termination of the research contract by the Research Fellow**

If the Research Fellow decides to withdraw from the contract, he/she is obliged to send a written notification with at least 30 days of advance notice to the Tutor and to Director of the Department. In case of late or lack of notice, the amount corresponding to the missing notice period will be deducted from any payment due.

#### **Art. 13 – Personal data**

Personal data transmitted by candidates with the application form will be treated in accordance with the scope of the appraisal procedure and eventually for the drafting and management of the resulting agreement with the University. All data are treated according to the University Regulations on Privacy. At any time, candidates can exercise their rights to have their data amended or cancelled as per the above mentioned regulations.

#### **Art. 14 –Governing laws**

For all matters not specifically mentioned in this call, reference should be made to the Regulations on Research Fellowship D.R. n. 654 of 22.06.2015 and other statutory regulations in force.
